

Schedule 1 - Appointed officers and committees

The Charles Sturt University (Student Misconduct) Rule 2020 (the Rule) authorises the Vice-Chancellor to appoint appointed officers and define the matters they can hear and decide in this schedule.

For clarity and to maximise usefulness of the schedule, it also collates authorities that the Rule grants to appointed officers, student misconduct committees and appeals committees. Should this schedule contradict the Rule on any point, the Rule overrules this schedule.

The Rule permits an appointed officer or committee to obtain advice or help from another person, or authorise another person to investigate an allegation, although the appointed officer remains responsible for the investigation/or decision.
