A stole of red corded fabric (PMS199) with two tails (each 100 cm long and 10 cm wide), fixed to a collar 33 cm wide, with rounded corners (5 cm radius) cut at the back of the neck 3 cm deep by 14 cm wide.  A 3 cm stripe in the faculty colour down the centre of each tail.	No trencher or headwear.
Diploma and associate degree	A black cloth gown in the style of a Bachelor of Arts gown of the University of Cambridge.	A stole of red corded fabric (PMS199) with two tails (each 100 cm long and 10 cm wide), fixed to a collar 33 cm wide, with rounded corners (5 cm radius) cut at the back of the neck 3 cm deep by 14 cm wide.  A 5 cm stripe in the faculty colour down the centre of each tail.	A black trencher cap and black tassel 30 cm in length.
Bachelor and bachelor (honours) degree	A black cloth gown in the style of a Bachelor of Arts gown of the University of Cambridge.	A hood of red corded fabric (PMS199) in the Cambridge full shape style lined 10 cm and bound 1.2 cm over the cowl with silk-like fabric of the faculty colour.  The neckband is lined in the faculty colour and attached so that when worn	A black trencher cap and black tassel 30 cm in length.

Graduate certificate and graduate diploma	A black cloth gown in the style of a Bachelor of Arts gown of the University of Cambridge.	A hood of red corded fabric (PMS199) in the Cambridge full shape style, lined 3 cm in blue silk-like fabric (PMS286), then a further 10 cm and bound over the cowl 1.2 cm with silk-like fabric in the faculty colour.  The neckband is lined in the faculty colour and is attached so that when worn the colour will show as a continuation of the colour in the cowl of the hood.	A black trencher cap and black tassel 30 cm in length.
Master degree	A black cloth gown in the style of a Master of Arts gown of the University of Cambridge.	A hood of red corded fabric (PMS199) in the Cambridge full shape style, lined 5 cm in blue silk-like fabric (PMS286), then a further 15 cm and bound over the cowl 1.5 cm with silk-like fabric in the faculty colour.  The neckband is lined in the faculty colour and is attached so that when worn the colour will show as a continuation of the colour in the cowl of the hood.	A black trencher cap and black tassel 30 cm in length.
Professional doctorate	A gown of lightweight red corded fabric (PMS199) in the style of a Doctor of Civil Laws of the University of Oxford. The front and sleeve facings are 12 cm wide from underarm to sleeve edge in the faculty colour.	A hood of blue corded fabric (PMS286) in the Oxford doctorate shape, fully lined and bound 2 cm over the cowl with silk-like fabric to match the facings on the gown.	A black Tudor bonnet trimmed with gold cord and gold tassels.



Doctor of philosophy	A gown of lightweight black fabric, similar to a master gown, but with a 10 cm front facing in red silk-like fabric (PMS199).	A hood of red corded fabric (PMS199) in the University of Cambridge full shape style, fully lined and bound 2 cm over the cowl in blue silk-like fabric (PMS286).  The neckband is lined in blue (PMS286) and attached so that when worn, the colour will show as a continuation of this colour in the cowl of the hood.	A black Tudor bonnet trimmed with a red cord and red tassels (PMS199).
Higher doctorate	A gown of lightweight blue fabric (PMS286) in the style of a Doctor of Civil Laws from the University of Oxford, with front facings and sleeves in the faculty colour.	A hood of red corded fabric (PMS199) in the Oxford doctorate shape, fully lined and bound 2 cm over the cowl with silk like fabric in the faculty colour.	A black Tudor bonnet trimmed with gold cord and gold tassels.

## Table 3: Aboriginal and Torres Strait Islander Stole

Award	Gown
Aboriginal stole	A stole 230 cm long made up of black, yellow and red stripes each 2.5cm wide, lined with black fabric and trimmed with yellow fringing, worn with the black stripe on the outside and red stripe on the inside.
Torres Strait Islander stole	A stole 230 cm long made up of blue, white and green stripes each 2.5cm wide, lined with black fabric and trimmed with black fringing, worn with the blue stripe on the outside and green stripe on the inside.
