### **TAFE NSW - Western Institute Award (Bathurst)**

Value	The Prize will be a cheque to the value of \$250 and an inscribed certificate issued by the the University.	
Presentation	Graduation Ceremony.	
Selection Procedure	Prizes Committee consisting of a representative from each of the five faculties of the the University (nominated by the Executive Dean of each Faculty) and a TAFE representative from the the University/TAFE Link Committee.	
Special Conditions	The prize may be withheld in any year if, in the opinion of the prizes committee, no student is of sufficient merit to justify its award.
